### 1. Placing Order

Order can be submitted via email, phone, or fax. Orders submitted and paid for before 3:30 PM Pacific Time are typically shipped out the same day. Dropship service also available. For more information about our dropship service please contact us.

### 2. Payment

Payment may be made by C.O.D. Money Order or Cashier's Check, Wire Transfer, or Credit Card (Visa or MasterCard).

### 3. Shipping

Shipping service will be provided by UPS, USPS, or third party freight forwarder. Each refused or undeliverable package will be subject to a return shipping charge of \$50.00 or less.

### 4. Inspection & Acceptance of Products

Shipment should be inspected before receipt for any visible sign of damage. Dealer should promptly notify the shipping service of any such visible sign of damage and have the delivery personnel acknowledge any such damage. After delivery Dealer should promptly inspect the shipment for any disparity. If any disparity is found, Dealer should contact Prima USA within 2 business days of delivery.

### 5. Returns

Any returns will be subject to a 15% restocking fee. Any returns must be in their brand new, unused condition.

### 6. Confidentiality

Prima USA pricing information, inventory level, credit terms, and advance product information should be kept confidential by the Dealer unless otherwise released by Prima USA.

### 7. Warranty and Return Merchandise Authorization (RMA)
